Brasseur speaks highly of the many advantages of operating the DC in Bedford County.

"The greatest advantage of doing business in Bedford County is our people. The central Pennsylvania corridor has long been known for having some of the best work ethic in the country. Our associates are the reason we have won DC of the Year honors six times. We continue to contribute to Walmart's strong performance," he said.

The Bedford DC is also proud of its deep connection to the community and shows it through its many hours of volunteerism.

Brasseur explained: "In 2016 we were honored to be awarded Volunteer of the Year from Downtown Bedford, Inc., for the volunteerism we do in our community and for their organization."

In the past 12 months, the Walmart Bedford DC has supported Bedford Food Outreach and the St. Vincent de Paul Food Banks with volunteerism and more than \$1.3 million of in-kind donations.

In 2017, Brasseur expects that DC associates will issue \$30,000 in grants from the Walmart Foundation Community Grant Program to local profits. The Walmart DC is involved with many other local programs, including the Women's Global Economic Empowerment initiative, the Veterans Welcome Home Commitment, sustainability practices and company giving.

## OMNI BEDFORD SPRINGS RESORT AND SPA CONTINUES TO GROW New clubhouse opened



The great promise of the Omni Bedford Springs Resort and Spa continues to reach new heights and new audiences.

"It looks like this will be our busiest year yet," said Omni General Manager, Bill Liedholm. "We expect to employ more than 500 employees this summer."

The Resort expects to accommodate about two weddings each weekend. "We host about 70 to 80 weddings a year," said Liedholm. "This is a beautiful property so we have many outside weddings."

To mark the 10th anniversary of the re-opening of the Omni Bedford Springs Resort, the company dedicated a new clubhouse for the golf course.

The design and finishes pay homage to the resort's history while also incorporating modern amenities and elements. Dating back to 1895, the Old Course is one of the country's first golf courses, designed by golf architectural masters Spencer Oldham, A.W. Tillinghast and

Donald Ross. The Clubhouse at the Old Course will honor the history and nostalgia of the historic course while bringing entirely new offerings to guests.

The \$2.5 million clubhouse is 6,000 square feet with an 80+ seat restaurant, Tillie's, including indoor and outdoor dining, a fire pit lounge area, pro-shop and locker rooms.

Liedholm appreciates the high quality of his staff.

"The people who work here are hardworking and genuinely welcoming," he said. "They share our Omni core values and a vision for what this property can become."

## BEDFORD COUNTY'S MISSION CRITICAL SOLUTIONS HOSTS SMALL BUSINESS WEEK KICKOFF

Pennsylvania's Small Business Week was launched this spring at the Mission Critical Solutions facility in Alum Bank.

Neil Weaver, executive deputy secretary of the Pennsylvania Department of Community and Economic Development, officially launched Small Business Week.

"Small businesses are the backbone of our economy," Weaver said. "There are 1.2 million small businesses in Pennsylvania employing 2.5 million workers. Small Business Week is designed to educate, bring awareness and let small businesses know what is available to them. It's not just funding, but also networking and supplier lists."

The event's host, Mission Critical Solutions offers a full range of engineering, fabrication and machining services. MCS makes products used by the Department of Defense and the railroad industry. Currently, MCS manufactures some 1200 different parts for the international railroad industry as well as important products for the Department of Defense.

"We have been able to assemble a world class workforce," said Bob McGowan, CEO, MCS. Founded in 2008, with four employees working in a 9,000-square foot facility, the company has grown to 60 employees in a 50,000-square foot plant. The company's revenues have doubled for the last three years.

Green Leaf Medical, LLC, a Maryland-based company, recently purchased the 274,000 square-feet former Seton facility in Saxton. Green Leaf Medical is a leader in the growing and processing of medical cannabis.

For more than three decades, Seton was a nationally recognized manufacturer of high end automobile interiors. Due to a declining domestic market, Seton closed its Saxton plant in 2008.

Now, Green Leaf Medical hopes to use part of the building, known as Saxton Business Center for its medical cannabis business. Additionally, it will provide leasing opportunities for companies seeking space to grow and expand.

#### GROWING IN MANY AREAS, LAMPIRE DEVELOPS NEW CAPABILITIES



"We are definitely growing in many areas," said Gregory F. Krug, president of Lampire Biological Laboratories. "We have increased our technical production staff and the staff's level of expertise."

Bedford County is positioned to reap the benefits from Lampire's recent growth. The company has expanded its capabilities in the antibody arena, in particular large production volume.

Lampire has added many new animals at its Everett farm and increased the available infrastructure there.

"At our Everett facility, we have added a two-story, 12,000-sq.ft. state-of-the-art building to help in the production of two key diagnostic tests," said Krug.

Lampire currently produces products from 500 animals in one building alone.

Additionally, Krug has mentored an entrepreneur, Karen Hoskins, helping her to grow her company, H. B. Custom Media, Inc. "Eventually, I saw a lot of synergy between her company and Lampire," said Krug. He recently pur-

chased H. B. Custom Media, Inc. "Karen's products and our culture bags are a natural fit for Bedford County."

A new arena for Lampire is stem cells. "We are now able to enter that marketplace," said Krug.

Lampire has grown steadily since its inception in 1977. The company now manages two expansive animal facilities, totaling over 450 acres in some of the finest agricultural country in North America.

These sites house large domestic farm animals and small laboratory animals for custom antisera, bulk sera, plasma, and red cell production programs. In addition, we now offer quality raw materials from New Zealand.

With the addition of a 18,000-sq. ft. laboratory in Everett, PA, Lampire now has three separate facilities for the processing and finishing of products. This facility increases its capacity for contract control manufacturing, hybridoma development, cell culture services, protein purification, bulk filtration, and antibody processing.

## SHAWNEE STATE PARK NAMED PARK OF THE YEAR A Bedford County gem is lauded

An important contributor to the quality of life in Bedford County is the Shawnee State Park.

This year, the park's pivotal role in the region was highlighted by its being named Park of the Year by the Pennsylvania Parks and Forests Foundation.

Shawnee State Park covers 3,983 acres of scenic ridges and valleys with a 451-acre lake for boating, fishing and swimming. There are 15 miles of hiking trails, five pavilions, three boat launches, and permissible hunting over 3,000 of the acres. The park also has more than 200 camp sites.

Park Manager Dorothy Krupa, was very humbled by the designation and especially pleased for her staff and the Friends of Shawnee, a volunteer group. The park was nominated for this award by Caytlin Lusk, an outreach specialist for REI.

"This award speaks volumes about what is valued here in Bedford County," stated Doug Gerber, BCDA board chair. "And the fact that the park was nominated
